- (iv) Time Adherence (3 minutes)
- (v) Audience Impact: Connection, energy, and overall response from the crowd.

- e. Participants must speak on the topic they select.
- f. Participants may take a second pick but they will be required to speak on the topic selected thereafter.

# 4. Cosplay

Participants per House: 3

Participants must not reveal their names on stage.

### Guidelines:

- a. Each house may debut a minimum of two and a maximum of four participants.
- b. Costume requirement:
  - 1. Participants can present in any costume of their choice.

- 2. Props must be safe and non functional.
- 3. At least 50-60% of the costume should be self-made.
- c. Each participant will get about 2-3 minutes on stage. Participants can prepare action sequence and moves including a walk and a signature pose.
- d. Registration requirements (Must be done in advance):
  - 4. Name, semester and house.
  - 5. Character name.
  - 6. Source (anime, movie, game, books)
  - 7. Reference image; bring the front and back image of the character being portrayed in an A4 size paper in colour and submit at the judges table before the performance.

#### 5. Quiz

- (ii) First Round: Each house will receive three direct questions, worth five points each, with no negative marking. Each question will be given a time limit of 30 seconds.
- (iii) Second Round: Teams must answer within fifteen seconds; correct answers earn five points and unanswered questions will be passed to the next house for bonus points.
- (iv) Third Round (Rapid fire): An open round where the first correct response earns ten points; wrong answers incur minus five points.
